WHEREAS, The voters of the Lakeside Fire District of Navajo County voted in favor of adopting the 2006 International Fire Code for the Lakeside Fire District which later merged with the Show Low and Linden Fire Districts to create the Timber Mesa Fire and Medical District;

WHEREAS, According to A.R.S. Title 48-820 M. If the merger is approved pursuant to subsection B or K of this section, the governing body of the newly merged district may adopt a nationally recognized fire code with the approval of the state fire marshal and after a hearing held pursuant to posted and published notice as prescribed by section 48-805.02, subsection A. The district shall keep a copy of the adopted fire code on file for public inspection.
