8. BUSINESS

A. Discussion and Possible: November Financial Report

Gabe Buldra, Finance Director, James Vincent Group, referred the board members to the November 2017 Financial Report in their packets. He discussed the key points of the report, which included revenues and expenditures.

He also reported that he and Melissa Tomlinson, Senior Consultant-James Vincent Group, will be teaching the class, "Understanding Internal Controls" at the AFDA conference in January.

Chair Dennis Hughes made a motion to approve the financial reports for the month of November 2017 as presented, and Member Lynn Browne-Wagner seconded the motion. The vote was unanimous and the motion carried.

B. Discussion and Possible Action: Review and revise Policy 1.08 Probationary Period

The District has had several promotions in the past several months, and through this process it has been determined that a provision in the Policy concerning probationary periods does not effectively meet the needs of the District. That provision is found in the Probationary Period Policy where it disallows an employee on probationary status to participate in a testing process for promotion. After consulting with our Human Resource Contractor and our staff it is the recommendation to remove the provision in policy limiting employees ability to test form promotion. There are several other provisions in Policy that allow for adequate control over the promotional process which makes this provision unnecessary.

Clerk Amy Kay made a motion to approve the Policy 1.08 Probationary Period removing Paragraph 1 as recommended by staff, and Lynn Browne-Wagner seconded the motion. The vote was unanimous and the motion carried.

C. Discussion and Possible Action: Fire District Governing Board Officer elections

It states in the Fire Board bylaws the Members of the Governing Board of the District shall appoint the then current Clerk to the Chairperson position. Members of the Governing Board of the District shall also select from amongst their numbers a Clerk of the Board. Clerk Amy Kay will be appointed the Chairperson of the Board. Clerk Amy Kay nominated Member Ed Lindquist to the Clerk of the Board, and Lynn Browne-Wagner seconded the motion. The vote was unanimous and the motion carried.
