8. BUSINESS

A. Discussion and Possible: Ratification of Governing Board action on October 22nd, 2018 to approve the minutes of a Special Board Meeting which took place on October 3rd, 2018

Board Clerk Ed Lindquist made a motion to ratify the previous action to approve the minutes of the Special Board Meeting of October 3rd, 2018, and Board member Dennis Hughes seconded the motion. The vote was unanimous and the motion carried.

Legal Counsel recommended that the motion include Items 8 C, D and E. Board member Dennis Hughes motioned that the newly consolidated Fire District review and approve Resolution 2018-8, retain John Flynn from the firm Policy Logic, LLC to assist in the transition of White Mountain Lake Fire District into the Timber Mesa Fire and Medical District, and to consider an amended budget to accommodate the White Mountain Lake Fire District and the Timber Mesa Fire and Medical District. Board member Lynn Browne-Wagner seconded the motion. The vote was unanimous and the motion carried.

D. Discussion and Possible Action: Proposal to retain John Flynn from the firm Policy Logic, LLC to assist in the transition of White Mountain Lake Fire District into the Timber Mesa Fire and Medical District
