9. BUSINESS

A. Discussion and Possible Action: September 2021 Financial Reports

Mr. Gabe Buldra, Principal for James Vincent Group, presented the monthly financials for September 2021 which include the Balance sheet, Summary of reconciled cash balances, Income Statement of Revenues and Expenditures, Capital Estimated vs Actual expenses YTD, Income vs. Expenses graph, Monthly Disbursement report and 12-month cash flow. He informed the Board that the first half taxes were in with just under \$2 million available. Revenues are strong so the line of credit was not needed. Revenue for the month of September is \$884,767 which is over budget by \$267,191 due to property tax collection, ambulance revenue and wildland revenue. Mr. Buldra let the Board know that the ambulance rate increase application has been submitted to DHS. Expenses for September total \$1,074,146 which is under budget by \$55,662. Year-to-Date revenue is \$1,771,610 which is \$213,112 over budget. Year-to-Date expenses are \$3,038,813 which is \$123,346 under budget.

Chair Dennis Hughes moved that we approve the financial reports for the month of September 2021 as presented, and Clerk Amy Kay seconded the motion. The vote was unanimous, and the motion carried.

B. Discussion and Possible Action: Policy 4.02 Holidays

Chief Chevalier referred the Board to Policy 4.02. The changes were recommended by the District's Human Resources consultant to update language, conform to current law, and adjust policy to match current best practices.

C. Discussion and Possible Action: Policy 4.06 Accidental Death and Dismemberment/Cancer Insurance Chief Chevalier referred the Board to Policy 4.06. The changes were recommended by the District's Human Resources consultant to update language, conform to current law, and adjust policy to match current best practices.

Chair Dennis Hughes moved that we approve the changes to Policy 4.02 Holidays, 4.06 Accidental Death and Dismemberment/Cancer Insurance, Policy 4.08 Arizona State Retirement Benefits and Policy 4.11 Modified Duty Assignment as presented, and Member Paul Wyatt seconded the motion. The vote was unanimous, and the motion carried.

F. Discussion and Possible Action: Approval of Cooperative Staffing Agreement between the Arizona State Fire Training Committee and the Timber Mesa Fire and Medical District

Chief Chevalier referred the Board to the draft MOU included in the board packet. Mr. Whittington helped craft the document. Discussion ensued regarding the process and reimbursement. Chief Wood gave some background on the State Training committee and his involvement.

Chair Dennis Hughes moved that we approve the Memorandum of Understanding between the Timber Mesa Fire and Medical District and the Arizona Center for Public Safety Excellence – Training Committee to employ the two members of the State Training Committee and have that committee reimburse the Fire District fully for any employee related expenses, and Member Paul Wyatt seconded the motion. The vote was unanimous, and the motion carried.
