

FIREFIGHTER PARAMEDIC

The Timber Mesa Fire and Medical District (TMFMD) invites applicants for the position of Firefighter Paramedic (CEP). This is a great opportunity to become a valuable member of a dynamic team in the fire service. The ideal candidate for the position will have a working knowledge that is familiar with fire district operations. We are accepting lateral firefighter paramedics. We will give credit for each year in PSPRS, up to step 6 on a 12 step pay scale.

We are inviting anyone who meets 100% of the job requirements or will meet 100% of the job requirements at time of hire or in the next 12 months. This means any FF I and II individual who is in a current CEP course, or a CEP who is in a current FF I and II course should apply.

JOB REQUIREMENTS

- Be at least 18 years of age
- A high school diploma or GED
- Possess, or able to obtain by time of hire, a valid Arizona driver's license
- Arizona Firefighter I and II certification or equivalent by time of hire or in the next 12 months
- Arizona Paramedic certification by the time of hire or in the next 12 months
- Must be currently contributing to or meet eligibility requirements to participate in AZ PSPRS
- Healthcare Provider Level CPR, ACLS, and PALS certification
- Be able to speak, read, and write the English language
